The major points discussed during the IQAC Meeting were as follows:

Preparation of Course Completion and Review Report

The committee members discussed that, at the end of the course, the faculty members should prepare a report stating the attainment of course outcomes and improvements required in pedagogy, course contents based on CO attainment. The assessment methods should be discussed with the HOD before finalizing the course plan. At the end of the course, the faculty should calculate the Course Outcome attainment based on target attainment levels. Action to be taken for improvement of attainment levels should be noted down in the Course Completion and Review Report after discussion with HOD.

The students should also be assessed on their understanding of the course content and application to business problems through various tools as a part of pedagogy during the delivery of the course. The tools designed to evaluate the attainment of specific Course Outcomes are Mid-term test, Case Study, Presentations, Projects / Assignments, Quiz, role plays, viva-voce etc.

Learning Management System

It was discussed the Library should be updated with the use of latest technology which will facilitate the students as well as the staff to keep pace with the modern world of technology and are not left far behind.

ISO Audit reports of all departments

The suggestions/comments given by the ISO Auditors were discussed and IQAC Coordinator was asked to circulate the suggestions/comments to faculty members for improving the quality of academic work.

Faculty Development Programs

To continue encouraging the faculty members to attend FDPs, Workshops, Conferences/Seminar organized by various industrial bodies, institutions/universities. To continue with the weekly faculty seminars. Faculties should also be encouraged to

publish papers not only in reputed National and International Journals but also in ABDC, Springer, Sage etc.
